Students that participate in an alternative learning program (AEEP) benefit from a smaller more individualized learning environment. The new AEEP Program will offer students a wide array of benefits not commonly found in a large public or private school setting.

Benefits and Motivations for AEEP Programs:

- State of Florida approved curriculum that can be customized to suit the individual needs and learning pace for each child
- Self-paced learning
- Small group sizes (7-10 per group)
- One on one assistance
- Accomplish more academically than in standard school settings
- Provides guided and reasoned social interactions with peers and adults
- Provides a safer environment for children away from physical violence, drugs/alcohol, psychological abuse, racism, improper and unhealthy sexuality associated views

Open Door Policy:

Jumpstart has an open-door policy where the Parents/Legal Guardians are encouraged to stop in and participate in daily activities. Parents are able to freely enter the school at any time and without an appointment.

 - *Any other Family Member MUST OBTAIN ACCESS RIGHTS from Jumpstart Administration (TIME NOT TO EXCEED 15 MINS!)*

Code of Conduct:

Jumpstart Enrichment Centers is committed to helping children develop to their fullest potential; every individual who enters our door is required to treat all others and their property in a positive and respectful manner.

Jumpstart Enrichment Centers shall not permit, practice, or inflict any form of physical punishment, verbal or emotional abuse, or denial of physical necessities for any child in attendance.

Reporting requirements for suspected abuse or neglect of any child while in the care of a childcare facility is the responsibility of each staff member and required by the Florida Department of Children and Families and the State of Florida.

Jumpstart Enrichment Centers reserves the right as a PRIVATE facility at the discretion of the administration to have any child or adult expelled/removed from the facility at any time with or without cause.
